Subject: News and feedback about Havards SHGT No1.

Dear Investor or Supporter,

As of today, we have 91 members and some £71,000 committed, a good start to the minimum target of £330,000. We've had several questions over the first week that I'll hope to answer in this email.

**Question:** Can I only buy 200 shares?

- 200 shares at a £1 each is the minimum shareholding. Holding at least 200 shares you become a member of SHGT Community Benefit Society.
- With 200 being the minimum, shares are for sale individually up to a maximum of 10% of the shares sold, today that is number is 33,000 shares per person, child or organisation. So, if you wish to invest £2453 you can do that, likewise £275.

**Question:** if I have already purchased 200 shares and wish to buy more, can I?

- Yes.

**Question:** if the last question was yes, can I choose a different interest (0%, 2% or 4%) rate when buying more shares?

- Yes.

**Question:** If I've already bought shares and want to buy another 175 shares, can I?

Yes – however the online investment form can't be used as it requires at least 200 shares to be purchased. The answer is to contact [secretary@siophavards.cymru](mailto:secretary@siophavards.cymru) and I'll arrange a call to process the purchase.

**Question:** If I wish to buy shares for two children can I purchase 300 shares for the 1st child and 100 shares for the 2nd?

- Each child is treated as an individual purchase/member. The first child would be accepted as the minimum shareholding has been reached and exceeded, the 2nd child would need an additional 100 shares to be added to reach the minimum share purchase before the share certificates would be issued.

Annwyl Gefnogwr neu Fuddsoddwr,

Hyd heddiw, mae gennym 91 o aelodau a thua £71,000 wedi'i ymrwymo, dechrau da i'r targed lleiafswm o £330,000. Rydyn ni wedi cael sawl cwestiwn dros yr wythnos gyntaf y byddaf yn gobeithio eu hateb yn yr e-bost hwn.

**Cwestiwn:** A allaf brynu dim ond 200 o gyfranddaliadau?

- 200 o gyfranddaliadau am £1 yr un yw'r isafswm cyfranddaliadau. Gan ddal o leiaf 200 o gyfranddaliadau rydych yn dod yn aelod o Gymdeithas Budd Cymunedol SHGT.
- Gyda 200 yn lleiafswm, mae cyfranddaliadau ar werth yn unigol hyd at uchafswm o 10% o'r cyfranddaliadau a werthwyd, sef 33,000 o gyfranddaliadau fesul person, plentyn neu sefydliad heddiw. Felly, os dymunwch fuddsoddi £2453 gallwch wneud hynny, a £275 yn yr un modd.

**Cwestiwn:** os wyf eisoes wedi prynu 200 o gyfranddaliadau ac yn dymuno prynu mwy, a allaf?

- Ydw.

**Cwestiwn:** os mai ydw oedd y cwestiwn olaf, a gaf i ddewis cyfradd llog wahanol (0%, 2% neu 4%) wrth brynu mwy o gyfranddaliadau?

- Ydw.

**Cwestiwn:** Os ydw i eisoes wedi prynu cyfranddaliadau ac eisiau prynu 175 o gyfranddaliadau eraill, a allaf i?

Byddai'r plentyn cyntaf yn cael ei dderbyn gan fod yr isafswm cyfranddaliad wedi'i gyrraedd a rhagori arno, byddai angen ychwanegu 100 o gyfranddaliadau ychwanegol ar yr 2il blentyn i gyrraedd yr isafswm pryniant cyfranddaliadau cyn cyhoeddi'r tystysgrifau cyfranddaliadau.
