A minimum shareholding starts at just £200 but you can buy more, indeed up to 33,000 shares. Every shareholder becoming a Member of the Society, giving you a say in how Havards is run.

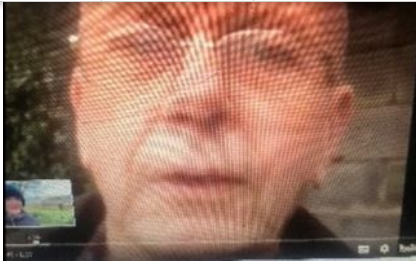
